### **CHURCH COUNCIL**

The Church Council has been communicating via Justin Arndt's Conference phone system. Below is the latest summary.

# **Conference Call Summary**

June 28, 2020

Discussion was opened by President Justin Arndt at 8:30 am.



The initial discussion was regarding the potential automobile-based service. Nalani and Lori are working with Steve Brueggen of Cashton. Galetta Brandau Memorial money will likely take care of equipment costs. There is a tentative Council trial on Tuesday, July 30. Nalani will inform of the time when it is established. The consensus was to begin services on the 12<sup>th</sup> of July. That should give time to have everything arranged and for the Pastor to become familiar. An article is to be placed in the County Line. People will likely be able to sit outside as well as inside their cars to listen to the service.

There is an additional problem with organ repair. The bellows on the side of the church opposite the organ requires removal either through the electronic pipe relay system or by creating a small hole in the wall directly in front of the bellows. The Council opted for the hole approach. Cost information is being sought. There is also a ceiling problem above the large pipes caused by an old leak. Residue is falling into the pipes. Information is also being sought regarding that problem.

A grilled chicken fund raising dinner is still pending. Lori is going to approach the Legion members in our congregation.

A letter will be sent to Sterling Schwartz to thank him for past work done for the church.

The conference call ended at 9:15 am.

#### Financial Report - Nalani

COVID-19

For the first six months of this year, expenses are projected to exceed offerings by \$5,170.47. Why do I use the term "projected" you ask? This article is being written on Friday, June 26 and although there are no additional bills to be paid before June 30, we may receive and deposit offerings between now and then. The following is a monthly breakdown of the aforementioned amount:

We have 98 households with assigned envelopes. Of that number, 48 households do not have a recorded offering for 2020. Of the remaining 50 households who did have recorded offerings up until the pandemic shutdown, 35 of those have continued their financial support.

# W-ELCA NEWSLETTER JULY/AUGUST 2020



# St. Paul's Drive-In Church Announced

Provided everything goes as planned (equipment set-up, test run, etc.), members of the church council have set July 12 as our first ever drive-in church service. We will also offer communion at this service.

How does this work? Members will park their cars in front of the church. The service will then be transmitted through your radio using a low band FM frequency. Tentatively, the council has also approved folks bringing lawn chairs, placing them on the sidewalk, 6 feet apart. Of course, a family unit may place their chairs closer. Well, you ask, how are these folks to hear the service? The service will also be piped over a portable sound system. That is why we are saying tentatively. We want to make sure this will not disturb our neighbors.

What about communion? How do we do that with social distancing? The church has purchased communion cups which also include a wafer. These cups will be distributed, prior to the service, by a member who will be wearing a mask and gloves.

The portable sound system and transmitter are being donated by the family of Galetta Brandau. You will be amazed at the portable sound system. Not only should this unit be perfect for the drive-in church, but it will be a great addition for Bible School, service in the park, as well as the Children's Christmas program.

We hope to see you on July 12.
