### Financial

October Financial Report: Nalani Bever; We finished the month of November with our current expense offerings in excess of our expenses by \$1,604.94. We have slowly crawled out of the hole and now are in a positive position of \$530.77 for the first eleven months. The chicken dinner had a net profit of \$4,080.82 so we are in a positive position of \$4,611.19.

### Pastor's Report:

1. Door Hangers--Pastor suggested that those houses within the range of the church's transmitter have door hangers placed on their front doors. The door hangers would include information about the times for the Christmas Eve services and the church's radio frequency, so people can tune in to the services.

2. Memorial Gift-- The family of Susie Ristow Zewiske (Julaine Summerfield Ristow and Jerry Ristow's daughter, and Linda Ristow Hall's sister) who passed away in 2014, has given a memorial gift to St. Paul's. They asked Pastor to designate how it should be used. Pastor suggested that it be used to purchase copies of a "walk through the Bible" book that we could use in 2021. Pastor is researching which book (title) we would purchase. The intent would be to have some books for the church library and/or to defray the cost of the books for parishioners who will participate.

3. Blue Christmas--December 21 is the longest night. On this evening, several churches have a Blue Christmas service. This is a service for those who are experiencing the loss of a loved one or other losses during this time. The Southwestern Texas Synod has prepared a video service and offered it for our use. The service will be sent to our email list, and if possible, the sermon and bulletin mailed to those without internet access.

4. Vacation--Pastor will take the last week in December as a vacation week. Bishop Arends will provide the sermon for the last Sunday in December. Pastor will prepare the bulletin for the service.
