*Pastor Cathy begins her ministry at St Paul's on March 1

Pastor Cathy was born and raised in Waukesha, Wisconsin. Her ancestors on her mother's side were from Bohemia, now known as the Czech Republic, and England. (Pastor Cathy has been told that there are many Czech people in Hillsboro, and some in Wilton.) Her ancestors on her father's side, came from Wales and Scotland, in the mid-to-late 1800's. They were farmers who tended livestock and crops in Great Britain, and upon coming to America, continued farming in rural Wales, Wisconsin. Her paternal grandfather moved the family into Waukesha, because he was allergic to hay, at a time when there was little medical assistance for such health issues. Thus, she grew up in Waukesha, surrounded by a large extended family.

Pastor Cathy's parents, John and Eloise Morris; and most of her other relatives were Presbyterians who lived out their Christian values. Her mother was a Bible major at Carroll College (now Carroll University). Her father came from a very religious family, which included her great uncle, (Rev.) Dr. Zachariah (Zac) Davies, who was a professor and chair of the Religion Department at Carroll College for 30 years. Her parents and brothers, Leslie, Richard and Robert; and she, attended First Presbyterian Church, almost every Sunday while growing up. Her parents were members, and when her brothers and she were confirmed, they became members, too. They participated in Sunday school, choir, Confirmation class, youth group, and many other activities. After graduating from high school, and during her entire adult life, Pastor Cathy has continued to attend church almost every Sunday and to be involved in the life and work of Christ's church in the communities in which she has lived.

In 2013, Pastor Cathy received a call to ministry in a dream. She told her boss about the dream, and that she would be quitting her job in the summer. She began looking at seminaries in which to study. She enrolled at the University of Dubuque Theological Seminary (UDTS), but her first class, was Summer Greek, at Wartburg Theological Seminary, a Lutheran seminary in Dubuque. She asked the housing coordinator at Wartburg if it would be possible for her to live in the residence hall while taking classes at UDTS. Thus, she began living at the Lutheran seminary. Her living at Wartburg Seminary, and participating in classes and worship there, helped her realize that she was being called to serve in rural ministry as a Lutheran pastor! She continued to discern her call while taking classes at Lutheran seminaries and completed her Master of Divinity degree at McCormick Theological Seminary. She participated in field experiences as a Synodically Authorized Minister at three Lutheran churches: First Lutheran in Glenville, Minnesota; Medo Lutheran in rural Mapleton, Minnesota; and Blair Lutheran in Blair, Wisconsin. She also completed her Clinical Pastoral Education (CPE) at Gundersen Hospital in La Crosse, Wisconsin. In May 2018, Pastor Cathy received her Certificate of Lutheran Learning and Faith Formation from Wartburg Theological Seminary.

Pastor Cathy has been called to share her love of God, her educational and administrative skills, and experience. She is looking forward to participating in the many activities of the church, Wilton community, and surrounding communities, and to be a shepherd for the flock of St. Paul's Lutheran Church.

Florence Dougherty

At the end of March, Florence Dougherty is retiring. To take a line from a hymn out of context, "the world is about to turn.' Florence has been St Paul's custodian since 1964. For many years before that, her parents, Art & Ella Brehmer, did the work.

Florence, until recently with husband John, were custodians in the largest sense of the word. Many think of the job as keeping the Church clean. That they did, the vacuuming, dusting, emptying the trash, etc.

But the basement floor had to be scrubbed & waxed periodically, more in the winter, the pews waxed once a year and then there was the outside work. The lawn needed to be mowed and the snow shoveled. Often the Doughertys donated their own equipment for the tasks.

Being custodian means opening and closing the building on Sundays and whenever there are meetings, turning up the heat or turning down the air conditioning, setting up and taking down tables, posting the hymn boards and more. And with Florence we had a bonus. John was a jack of all trades. He could fix the locks, repair the vacuum cleaners and make the basement floor shine. He was also a respectable furnace man and electrician.



For most of us, Florence has been the only custodian we've known at St Paul's. She's set the gold standard. From the congregation, thank you for a job well done. LB



Front Church Steps

As you know, attempting to find a solution for the crumbling front steps has led to finding additional problems. With the present codes, etc. it is impossible to simply replace the steps as is. The Council has determined that it is appropriate to look at the concerns raised by various Congregation members and develop an overall plan. As a start, President Dan arranged to meet with Anne Gerrietts, Church Building Consultant for ELCA Mission Investment Fund. This took place on Monday, February 11. Council members who were available were there as was Cathleen Morris (Pastor Cathy to us as soon as she is ordained) and her aunt.

Dan led the group on a tour of the church and explained the ideas that had surfaced so far. Ms. Gerrietts offered her thoughts as we moved along. She cited examples of what other similar churches had done and




said she would send examples and other information. Since one of the things being considered is expansion of the entry narthex, she suggested that this could be tried at no cost by removing a couple of pews in the back and setting up some coffee after church. She also suggested that the short pew for wheelchairs should be where the congregation actually sits if it isn't. Another point made was that it would be appropriate to move the office into the Church at some time.

She was impressed with the window & roof work already done. Also discussed was the value of having a complete renovation plan for the church so priorities could be set and the work done in stages that all fit together. Unless a congregation is significantly growing, it is unwise to take on too much debt at one time.

Dan also toured Ms. Gerrietts and Pastor Cathy through the parsonage and discussed the future of the parsonage, the pastor's needs and her move.

FYI - Prochnow Martalock

Every month the church treasurer presents a report of the reconciled balances regarding church finances. Two of the accounts are named for individuals. As time passes, their contributions to St. Paul's and the reasons for the account names fade. With that in mind, this is an effort to refresh the collective memory.

PROCHNOW YOUTH EDUCATION FUND

Named for Herbert V. Prochnow, this account is the result of stock given by him and the actions of the Finance Committee and Church Council. Born and raised in Wilton, Herbert V. Prochnow (May 19, 1897- September 29, 1998) was a banking executive, a noted toastmaster and author. He also served in the Eisenhower Administration in the mid 1950's. He maintained a residence in Wilton as well as an interest in St. Paul's. In June of 1968 he wrote a letter to Pastor Gary Flatgard citing the value of the stock he had purchased for the church and requesting two things: that the church provide flowers each year on the Sunday nearest his Mother's and Father's wedding anniversary and secondly that the " ... Church itself would never use the: principal funds " but the" ... income may be used as the church sees fit." At the May 7, 1969 Church Council meeting, a motion was passed to use the resultant dividends "primarily for youth work or at the discretion of the Church Council." In May of 200 1, at the recommendation of the Finance Committee, the Church Council passed a resolution regarding the Church Financial structure. A portion of that resolution follows.

The Prochnow Youth Education Fund shall be funded from three existing certificates of deposit, * as reported in the 2000 Annual report, totaling \$37,100. This funding and subsequent gifts or bequests shall be considered permanent principal. Investment income from these monies shall be used to assist in the youth education programs of the Church as under current Council policy.

* The certificates of Deposit that hold the principal have since been combined and are listed as Herb Prochnow Memorial Funds on the Finance reports with the described Youth Fund listed separately. These funds have been loaned internally for such projects as the roof work but returned in full with interest being paid to the youth fund.


MARTALOCK SUSTAINING FUND

Named for Louella Wendorf Martalock, this account is the result of a bequest from her estate and the actions of the Finance Committee and Church Council. Louella Wendorf Martalock (December 19, 1907 - July 14, 1999) was a long-time teacher in the Wilton area, retiring as a 6th grade teacher at Wilton Elementary. For many years she was the organist for St. Paul's. As a result of the bequest, at the May 15, 2001 Church Council meeting, the following recommendation from the Finance Committee was adopted.

The Martalock Sustaining Fund shall be initiated with initial funding of \$8,000 from the Louella Martalock bequest of\$25,000. This initial funding and subsequent gifts or bequests shall be considered permanent principal. Investment income from these monies shall be used to assist in sustaining the general budget of the Church. At the direction of Council, the Treasurer may borrow from the trust principal amounts sufficient to sustain General Account balances necessary to meet the monthly obligations of the Church. Such borrowings from principal shall be repaid by year end from the General Account or by special offerings.

The sustaining fund has been used as described on numerous occasions. It has proven its worth as a cash flow fund, and has been repaid as funds allowed. The remainder of Louella's bequest was used to establish a sub-fund in the Improvement account for the eventual replacement of the organ. By Congregational action that fund has since been used for a more immediate need: the window project. Compiled by Larry Ballwahn


